Eagle Bend North's Annual Meeting will be held on Wednesday, August 9, 2023, at the Eagle Bend Yacht Harbor Club House. The meeting starts at 3:00 p.m., followed by a social gathering with hors d'oeuvres.

Road sign improvements (submitted by Steve Armstrong) A discussion took place at the Annual Meeting in August 2022 regarding the state of the various traffic signs in Eagle Bend North. Homeowner Andy Phillips volunteered to examine the signs and provide recommendations to the Board. Andy performed a complete audit of all road signs, stop signs and speed limit signs. He recommended and the Board agreed that many of the street signs were severely faded from their past 30-years of exposure to weather. Andy painted all of the sign posts in a green color, actually making those posts more visible. Some of the posts will have to be replaced as they have been damaged primarily by landscaping equipment. Some lower Bridger Drive residents expressed concerns about speeding cars. EBN purchased new speed limit signs, one at the entry from Holt and the other from the entry from Golden Bear. These signs are much more visible, and hopefully, drivers will follow the recommended 15 mph speed limit.
