The empty lots are looking good and are being cut as usual. The marquees are the best around and all very eye catching. The marquees will be set up in April and May.

#### EBN irrigation of marquees and Nagy Park (submitted by Steve Armstrong)

The Board examined the cost of irrigation of the marquees and Nagy Park. EBN paid Bigfork Water & Sewer about \$14,000 for irrigation in 2023. Steve visited with Bigfork Water & Sewer about this expense and the Board discussed this concern at length at its March 6th meeting. The Board directed Management to work diligently to reduce the irrigation expense of Nagy Park, which is the greatest expense. Our hope is to reduce the irrigation expense of Nagy Park by at least half, preferably more, and irrigate only at night. This will be discussed in detail at the Annual Meeting on August 7, 2024.

#### **Snow removal** (submitted by Steve Armstrong)

Eagle Bend North had a new snow plow crew for our 2023-2024 snow season. In reality, we did not have as much snow as, say, the winter of 2016-2017. We directed Management to have the plow crew clear snow more frequently to reduce ice accumulation. Homeowners should not shovel their snow onto the street as this will create a pile which will freeze and interfere with the plow crew. As we have fewer vacant lots, the plow crew will have to be creative and diligent about where to place the plowed snow.
